### **ACTIVE MEMBERSHIP**

This category includes membership in the National Propane Gas Association for propane retail marketers and voting privileges.*

Propane retail marketer dues based on number of bulk plants:

- 0-2 Bulk Plants (combined price) or Headquarters = IPGA \$498 + NPGA \$498 = **Total \$996**
